The Lisle water system is classified as a Small Municipal Residential water system that currently serves approximately 78 homes. Water is supplied via two (2) municipal wells and one (1) pumphouse. Inspections and maintenance duties are conducted by Ontario Clean Water Agency staff on a regular basis to maintain compliance with Ontario Regulation 170/03 to ensure that Lisle’s water supply is safe to drink.
